## **INSTRUCTIONS**

## Census of Central Government Employees as on 31st March 200......

While filling up the returns CG-I, CG-IA and CG-II the following points for guidance may please be kept in view;-

- 1. CG-1 form is meant for collection of data on all employees in the establishment both regular and non-regular staff by pay-ranges. It may be mentioned here that a few establishments show distribution of employees, which is totally wrong. The distribution of employees must be shown by pay ranges on the basis of the basic pay drawn by each employee as on 31<sup>st</sup> March, 200\_\_\_\_\_\_.
- 2. Form CG-II is though identical to CG-I but the purpose of this return is to collect data on distribution of Central Government Employees by pay ranges according to the class of cities-A1, A, B1, B2 and C in which the staff is stationed. In case the staff of an establishment is stationed in different classified cities, separate CG-1A return is to be filled in for each classified city. No CG-1A return is required to be filled in for the staff stationed in unclassified city. Complete lists of classified cities are given at the back of CG-1A form. In case the staff of the establishment is located in only one city even then a separate CG-1A return is to be furnished apart from the CG-I since the CG-1A returns are completed separately.
- 3. CG-II return is meant for collection of data on distribution of Central Government Employees (Regular staff only) by category / class of post.
- 4. Before submitting the Returns it must be ensured that the total of regular staff shown in CG-I return must tally with those of the total in CG-II returns, similarly Gazetted and non-Gazetted and men and women total must also tally.
- 5. Before submitting the returns, relevant year may be mentioned.
- 6. Few establishments do not write clear and complete address of the establishments which create difficulties in condition of the returns. It is, therefore, requested that clear and complete address of the establishments with name of Ministry or Department and also the name and designation of the officer forwarding the Returns must be mentioned at appropriate place in Returns.
- 7. It is fact that this Census is conducted by the Directorate General of Employment and Training on behalf of the Department Expenditure, Ministry of Finance, Government of India and the results are utilized in making decisions on the matters concerning the payment of Dearness Allowance, H.R.A. and C.C.A. and other service matters concerning Central Government Employees.
